	New Business	NOTES
1.	Approval of June 7, 2021 minutes	A motion was made by Mr. Osbourne and seconded by Ms. Self to approve the minutes of the June 7, 2021 minutes. The motion passed.
2.	Online Application	Ms. Morrow informed the Council that online applications are now on the MSDH website, and all applicants can submit their application online instead of paper application. The tentative date for removing paper applications off the website is end of April.
3.	Renewal Update	Ms. Gunn provided an update of the renewal period. She informed the Council that we have 319 active licensees and 42 licenses expired at the end of the renewal period. Mr. Gunn also informed the Council that 5 new licenses have been issued in 2022.
4.	Website Changes	Ms. Morrow informed the Council of the recent website changes in which all professions are separated, each with their regulations and forms.
5.	Complaint Report	Ms. Wang informed the Council that the complaint forwarded to the Bureau is an EMS complaint, and not against an Athletic Trainer. The complaint has been forwarded to the EMS department. Also, Ms. Morrow informed the Council that there is now a complaint form on the MSDH website that can be submitted via DocuSign.
6.	Application Details	Mr. Frans asked if the application for requires applicants to give "race" as this is diversity grant requirement. Ms. Morrow informed the Council that the application only requires gender. The Council stated that a survey can be sent out via MATA.
7.	Safe Space Training	Ms. Berch questioned if safe space training is required for MSDH. Ms. Morrow informed it is not a requirement, but if wanting to make it required for licensees, it will require a regulation change. MATA will need to send a request to the Bureau in writing with additional information from other states as to why it should be required. For a regulation change, it will need to go to the Board of Health, which the next meeting is in July. Any CE requirement upon renewal will go into effect 30 days after the board meeting and approval.


