2.	LARS Online Applications	Ms. Morrow informed the Council that the Department is in the third testing phase of an online application system thru LARS. The Department hopes to have the online applications available before the end of the year.
3.	Licensure Report	Ms. Gunn provided a licensure status update. She informed the Council that we currently have 403 active athletic trainers. She has issued 15 new licenses to date. Ms. Berch inquired about the inactive licensees. Ms. Gunn informed her that she would follow up with an email that contains that information.
4.	2020 Renewal Reminder	Ms. Morrow reminder the Council that their renewal will begin November 1, 2021. Ms. Gunn stated that she will start sending information around mid-October. The licensees with email addresses in the system should receive an email notification. Ms. Berch stated the Association would notify their members and provide our contact information for questions.
5.	Complaints	Ms. Wang informed the Council that we received another complaint concerning individuals allegedly practicing as athletic trainers after a cease and desist order was issued. She stated that the Department will set up a meeting with the Director of Jackson State University's Athletic Department and consult with our legal department. Ms. Berch informed the department of another potential violation of a previous cease and desist order in South Panola. Ms. Morrow asked for details to be emailed to her for further review.
