



## CHANGES IN REGULATION FISCAL YEAR 2015

The following final regulatory actions were taken by the Mississippi State Board of Health in FY 2015:

#### **JULY 2014**

Final Adoption of Minimum Standards of Operation for Institutions for the Aged or Infirm.

 Informal Dispute Resolution process revised to delete the requirement for a community ombudsman to sit on the panel and replace the ombudsman position with a provider representative of the long term care community.

Final Adoption of Minimum Standards of Operation for Personal Care Homes – Assisted Living.

• Changed licensure fee to \$15.00 per bed with a minimum fee of \$100.

Final Adoption of Minimum Standards of Operation for Personal Care Homes –Residential Living.

• Changed licensure fee to \$15.00 per bed with a minimum fee of \$100.

Final Adoption of Regulations Governing Licensure of Occupational Therapists and Occupational Therapy Assistants.

 Allowed Occupational Therapists to receive Continuing Education credit for supervising Occupational Therapy and Occupational Therapy Assistant students, set the condition of supervision and limits the number of hours that can be earned by supervision of students as well as elimination of unnecessary wording and other technical amendments.

Final Adoption of Regulations for Tanning Facilities Removal from the Division of Radiological Health and Relocation to the Office of Environmental Health.

Amended regulations to comply with the Conference of Radiation Control Program
Directors Suggested State Regulations for Tanning.

#### OCTOBER 2014

Final Adoption of Amendments to the Mississippi Boiler and Pressure Vessel Safety Act Rules and Regulations.

• Modified rule on inspection fees to refer to fees specified in Miss Code Ann. 41–23–41, and to remove outdated contact information and other unnecessary language.

Final Adoption of Bureau of EMS Fee Schedule.

Added a new fee for the certification/re-certification of Critical Care Paramedic.

Final Adoption of the Regulations Governing the Licensure of Child Care Facilities.

- Amended rule to state that each child care facility is subject to inspection at any time and deleted rule that allowed re-measurement at any time.
- Added requirement that Child Care Licensure Office maintain a complaint hotline.
- Clarified amount of square footage required for each child care facility per child and how the square footage is measured.
- Amended conditions under which a child care facility is re-measured.
- Added a "Grandfather Provision" that allows a facility to maintain current maximum capacity if the square footage requirements are changed by regulation.
- Required child care facilities licensed after January 1, 2015 to have a fully functioning kitchen.

# CHANGES IN REGULATION FISCAL YEAR 2015

- Amended reasons for allowing a District Level administrative hearing.
- Specified that, at District Level administrative hearing, court reporter will not be allowed that the Department will not be represented by counsel and that the hearing officer will render a written order.
- Clarified the reasons for a State Level Administrative Hearing and provided that a court reporter will be present.
- Clarified that a licensee may be represented by counsel at a State Level Administrative hearing.
- Clarified the emergency situations under which a monetary penalty shall not be imposed.
- Added Appendix: Rule and Procedures for State Level Administrative Hearings.

Final Adoption of the Regulations Governing the Licensure of Child Care Facilities for 12 or Fewer Children in the Operator's Home.

- Amended rule to state that each child care facility is subject to inspection at any time and deleted rule that allowed re-measurement at any time.
- Added requirement that Child Care Licensure Office maintain a complaint hotline.
- Clarified amount of square footage required for each child care facility per child and how the square footage is measured.
- Amended conditions under which a child care facility is re-measured.
- Added a "Grandfather Provision" that allows a facility to maintain current maximum capacity if the square footage requirements are changed by regulation.
- Required child care facilities licensed after January 1, 2015 to have a fully functioning kitchen.
- Amended reasons for allowing a District Level administrative hearing.
- Specified that, at District Level administrative hearings, court reporter will not be allowed that the Department will not be represented by counsel and that the hearing officer will render a written order.
- Clarified the reasons for a State Level Administrative Hearing and provided that a court reporter will be present.
- Clarified that a licensee may be represented by counsel at a State Level Administrative hearing.
- Clarified the emergency situations under which a monetary penalty shall not be imposed.
- Added Appendix: Rule and Procedures for State Level Administrative Hearings.

Final Adoption of Amendments to the Mississippi On–Site Wastewater Disposal System, Rules and Regulations.

- Provided that openings covering the inlet and outlet shall be accessible and visible.
- Provided that in two compartment tanks, the first compartment must be between 60 and 67% of the total capacity of the tank.
- Provided that on two compartment tanks, the baffle forming the two compartments shall have an opening four to six inches wide; located in the center of the baffle at 50% of the liquid in the tank.
- Removed language to allow for additional synthetic fiber manufactures to register their products.
- Changed Septic Tank sizing requirements for residential facilities with more than six bedrooms and 12 occupants.
- Prohibited the use of metal tanks, drums, barrel or pipes in Individual On-site Wastewater Disposal System.
- Changed Advanced Treatment System Sizing.
- For Aggregate reduced the design calculation from 150 gallons per day/per bedroom to 130 gallons per day and revised the sizing chart.

## CHANGES IN REGULATION FISCAL YEAR 2015

- For Aggregate Replacement reduced design calculations from 150 gallons per day to 130 gallons per day, and revised the sizing chart.
- For Drip Irrigation Systems reduced design calculation from 150 gallons per day/per bedroom to 130 gallons per day and revised the sizing chart.
- For Spray Irrigation Systems reduced the design calculation from 150 gallons per day to 130 gallons per day.
- Provided that electrical equipment must be installed in a manner to eliminate potential contact with sewage or effluent, including connections.
- Provides that effluent should not be sprayed upon any vessel containing wastewater.
- Requires treatment and disposal components of the spray irrigation system be registered with the Mississippi State Department of Health as a system.
- Deleted the requirement for a selfopening relief valve.
- For Elevated Sand Mound reduced the design calculation from 150 gallons per day/ per bedroom to 130 gallons per day and revised the sizing.

Final Adoption of Appalachian Regional Commission "ARC" |-1 Visa Waiver Guidelines.

 Updated requirements for HIV and TB testing and treatment plans for candidates with positive results.

Final Adoption of Mississippi Conrad State 30 J-1 Visa Waiver Guidelines.

 Updated requirements for HIV and TB testing and treatment plans for candidates with positive results.

Final Adoption of Mississippi State Department of Health National Interest Waiver Guidelines.

• Updated requirements for HIV and TB testing and treatment plans for candidates with positive results.

Final Adoption of Rules and Regulations Governing Reportable Diseases and Conditions.

- Added chikungunya virus as a Class I Reportable Condition under the subsection Arboviral Infections.
- Added HIV infection in pregnancy as a Class 2 Reportable Condition.

Final Adoption of Regulations Governing Newborn Screening and Birth Defects Registry.

 Added newborn screening ro Severe Combined Immunodeficiency and Critical Congenital Heart Defects.

Final Adoption of FY 2015 Mississippi State Health Plan.

- Revised the statewide formula for Psychiatric Residential Treatment Facility (PRTF) beds.
- Allowed Level II rehabilitation facilities to convert up to 8 beds to Level I status under certain conditions.
- Established Residential Rehabilitation facilities for patients with brain and spinal cord injuries.

#### **JANUARY 2015**

The Board took no regulatory action during the January 14, 2015 meeting.

#### **APRIL 2015**

Final Adoption of Mississippi State Rural Health Plan.

 Provided a plan for rural health care specifically to define rural areas, rural health care facilities and rural hospitals, including but not limited to critical access hospitals.

Legislative Update for the 2015 Mississippi Legislative Session:

#### SENATE RESOLUTION 1. Immediate release 3/5/15.

 Recognizes Mississippi for having the highest national kindergarten vaccination rates and presents the resolution to the State Health Officer Dr. Mary Currier, forwarded to the State Board of Health and the Rural Health Clinics Association for distribution to the county health departments and made available to the Capitol Press Corps.

#### SENATE BILL 2108. Signed 4/13/15. Effective 7/1/15.

- Authorizes hospitals to provide each patient or the patient's legal guardian an opportunity to designate a lay caregiver after the patient's admission into a hospital and before the patient's discharge to the patient's residence. It requires hospitals to alert the designated caregiver when the patient leaves the hospital and to provide the caregiver with instructions on caring for the patient after release.

#### SENATE BILL 2124. Signed 3/31/15. Effective upon passage.

 Extends the repealer on Section 41-85-7, Mississippi Code of 1972, to July 1, 2018 to prohibit the Mississippi State Department of Health from processing any new applications for hospice licensure or issuing any new hospice licenses, except renewals, unless the application was pending March 1, 2013.

#### SENATE BILL 2185. Signed 3/17/15. Effective upon passage.

 Amends Section 37-13-134, Mississippi Code of 1972, to clarify the requirement for instruction in Cardiopulmonary Resuscitation (CPR) and the use of Automated External Defibrillator (AED) to be provided in physical or health education curricula to 9th graders.

#### SENATE BILL 2123. Signed 4/20/15. Effective 7/1/15.

– Extends the repealer on Sections 41–58–1 through 41–58–5, Mississippi Code of 1972, to July 1, 2018; Medical Radiation Technologist Definitions, Registration Requirements & Continuing Education Requirements. In addition, this legislation includes a change to "nuclear medicine technologist" to allow a certified nuclear medicine technologist to perform diagnostic CT exams on hybrid equipment for diagnostic purposes.

#### SENATE BILL 2407. Signed 4/22/15. Effective 1/1/16.

 Amends Section 25-41-3 et seq., Mississippi Code of 1972, to clarify that the Board of Trustees of public hospitals are subject to the Open Meetings Act.

#### SENATE BILL 2441. Signed 4/20/15. Effective 7/1/15.

 Authorizes the formation and defines "provider-sponsored health plans." Also requires the Department of Insurance to establish a process for the certification of provider-sponsored health plans and to set certain minimum requirements.

#### SENATE BILL 2485. Signed 3/29/15. Effective 7/1/15.

 Authorizes licensed physicians to prescribe or recommend certain investigational drugs, biological products or devices to certain eligible terminally ill patients.

#### SENATE BILL 2588. Signed 4/22/15. Effective upon passage.

– Amends Section 43–13–117, Mississippi Code of 1972, to a) extend the repealer to June 30, 2018 on the sections that define the health care services covered under the program, b) direct Medicaid to apply for a waiver to increase payments for adult day care facilities and sets the payment limit, c) authorizes Medicaid to establish a Mississippi Hospital Access Program, d) authorizes Medicaid to implement a

provider-sponsored health plan, and e) provides any health plans implemented may not override medical decisions of hospital physicians or staff regarding emergency room patients and specifies prior authorization of nonemergency patients not be subject to the restriction. Also extends repealers on hospital assessments and on UPL and DSH payments.

#### SENATE BILL 2687. Signed 3/17/15. Effective 7/1/15.

– Creates The Mississippi Direct Primary Care Act which Authorizes physicians to enter into a contract directly with a patient or an employer for the purposes of providing primary care at a fee for service. Exempts the contractual agreement from being considered insurance. Also exempts the provider from being considered a participant in the insurance business and from the requirement to obtain a license to promote and sell primary care contractual services.

#### HOUSE BILL 111. Signed 3/23/15. Effective 7/1/15.

 Amends Section 63-3-103 et seq., Mississippi Code of 1972, to define autocycles and exempts the operators of autocycles from the requirement to obtain a motorcycle endorsement for their driver's license. Also exempts operators from the requirement to wear a helmet.

#### HOUSE BILL 204. Signed 4/20/15. Effective 7/1/15.

- Amends Sections 73-6-5 et seq., Mississippi Code of 1972, to prohibit State Licensure Boards from conditioning the licensure of health care professionals on their participation in any public and private health insurance plan, the public health care system, public service initiative, emergency room coverage, or upon compliance with the Federal 'meaningful use' of electronic health records.

#### HOUSE BILL 215. Signed 3/17/15. Effective 7/1/15.

- Amends Section 73–25–18, Mississippi Code of 1972, to provide a special voluntary medical license to physicians serving in active duty of the Armed Forces or the Department of Veteran Affairs as eligible to donate care to indigent, needy or medically underserved patients in the state. Also establishes physician assistants as eligible under the same conditional requirements set for physicians.

#### HOUSE BILL 257. Signed 3/13/15. Effective 7/1/15.

 Requires HIV testing for all persons arrested for commission of a sex crime against a minor.

#### HOUSE BILL 389. Signed 3/13/15. Effective 7/1/15.

- Creates a texting while driving law which prohibits any person operating a moving motor vehicle from writing, sending, or reading a text message and from accessing, reading or posting to a social networking site using a hand-held mobile telephone while driving. Violation of this law is punishable by a civil penalty of \$25.00 for violations before July 1, 2016 and \$100.00 for violations committed from and after July 1, 2016. This law stands repealed July 1, 2018. The current law, Section 63–1–73, Mississippi Code of 1972, which prohibits texting while driving under certain licenses, is repealed.

#### HOUSE BILL 434. Signed 4/22/15. Effective upon passage.

 Amends section 41-113-11, Mississippi Code of 1972, to provide 32 that any funds appropriated from the tobacco control program fund that are unexpended at the end of a fiscal year shall lapse into the tobacco control program fund; Amends

section 43–13–407, Mississippi code of 1972, to provide that any funds appropriated from the health care expendable fund that are unexpended at the end of a fiscal year shall lapse into the health care expendable fund; directs the state fiscal officer to transfer the entire balance in the health care trust fund to the health care expendable fund during fiscal year 2015.

#### HOUSE BILL 544. Signed 3/13/15. Effective upon passage.

 Amends Section 43-13-121, Mississippi Code of 1972, to authorize the Division of Medicaid to extend certain management information system and support contracts for a period not exceeding 5 years.

#### HOUSE BILL 545. Signed 4/23/15. Effective 7/1/15.

- Amends Section 43-13-107 et seq., Mississippi Code of 1972, to remove requirements for the Pharmacy and Therapeutics Committee to meet at certain intervals and specifies the time frame for filing Judicial Appeals against the Division.

#### HOUSE BILL 583. Signed 4/23/15. Effective upon passage.

- Amends Section 41-7-191, Mississippi Code of 1972, to exempt from the Certificate of Need review process the planning, design, construction, renovation, addition, furnishing and equipping of a clinical research unit at the University of Mississippi Medical Center located in Jackson, Mississippi. Also, exempts the repair or rebuilding of a health care facility that sustained significant damage from a natural disaster that occurred after April 15, 2014. In addition, amends Section 41-7-207, Mississippi Code of 1972, to clarify the authority of the Mississippi State Department of Health to issue a Certificate of Need under an expedited review process to alleviate an emergency condition. Section 41-7-191(19) stands repealed June 30, 2016.

#### HOUSE BILL 692. Signed 3/13/15. Effective 7/1/15.

- Creates the "Emergency Response and Overdose Prevention Act." Allows another person acting in good faith to administer an opioid antagonist to a person whom he or she believes to be experiencing an opioid-related overdose. It also creates the "Mississippi Medical Emergency Good Samaritan Act" to provide immunity or prosecution for certain drug violations for people seeking treatment for a drug overdose.

#### HOUSE BILL 831. Signed 4/22/15. Effective 7/1/15.

- An act to amend section 27-103-159, Mississippi code of 1972, to require all state agencies in the fiscal year 2017 budget presentation and annually thereafter to provide a list of all fees, fines and taxes assessed or collected by the agency and the basis for the method of assessment; to amend section 27-103-129, Mississippi code of 1972, to require the legislative budget office to publish on its website the budget requests submitted under the authority of this section by state agencies, special-fund agencies and general-fund agencies; to create the Mississippi fines accountability and transparency task force; to describe the purpose of such task force; to list the members of the task force; to provide the duties and powers of the task force; to provide a dissolution date for the task force; and for related purposes.

#### HOUSE BILL 873. Signed 3/23/15. Effective 7/1/15.

 Amends Section 25-15-15, Mississippi Code of 1972, to prohibit the State and School Employees Health Insurance Management Board from assessing premium charges or other premium changes to plan participants based on the use or non-use of tobacco products until 2018.

#### HOUSE BILL 885. Signed 3/26/15. Effective 7/1/15.

 Requires health insurance policies to provide coverage for autism-related treatment and creates the Mississippi Autism Board to license and regulate the practice of applied behavioral analysis.

#### HOUSE BILL 910. Signed 4/23/15. Effective upon passage.

 Creates the Infant Mortality Reduction Collaborative. The Collaborative will make annual policy recommendations to the legislature and recommendations for regulatory changes to state agencies for various matters. The Collaborative will be assigned to the Mississippi State Department of Health for administrative purposes. Stands repealed July 1, 2017.

#### HOUSE BILL 952. Signed 4/23/15. Effective 7/1/15.

- Creates new Section 83-9-24, Mississippi Code of 1972, to prohibit health plans from requiring a higher copayment on oral anti-cancer medications based on administration by a patient or health care provider. Also, it authorizes the State and School Employees Health Insurance Management Board to accept bids for bundled surgical services for the State and School Employees' Health Insurance Plan.

#### HOUSE BILL 1251. Signed 4/20/15. Effective upon 7/1/15.

 Amends Section 63-3-103 et seq., Mississippi Code of 1972, to allow motor scooters to be operated without the requirement to obtain a motorcycle license. This authorizes municipalities and the Institutions of Higher Learning to enact rules and regulations for the operation of rented motor scooters within their municipalities and college campuses.

#### HOUSE BILL 1393. Signed 4/13/15. Effective 7/1/15.

- Extends the repealer of Section 73-17-11, Mississippi Code of 1972, to July 1, 2018 for the licensure requirement for nursing home administrators. Also exempts the State Department of Mental Health administrators of mental health and disability programs from the requirement to obtain an administrator's license.

#### HOUSE BILL 1555. Signed 4/20/15. Effective 7/1/15.

- An appropriation for the purpose of defraying the expenses of the State Department of Health for the fiscal year 2016.







#### AIDS RATES BY YEAR, UNITED STATES AND MISSISSIPPI, 2004-2013




#### TUBERCULOSIS RATES BY YEAR, UNITED STATES AND MISSISSIPPI, 2005-2014




#### WEST NILE VIRUS RATES BY YEAR, UNITED STATES AND MISSISSIPPI, 2005-2014








