



The following final regulatory actions were taken by the Mississippi State Board of Health in FY 2017:

JULY 2016

Final Adoption of Minimum Standards for Abortion Facilities

Amended the regulations to include additional definitions pertinent to abortion facilities including language which prohibits dismemberment abortion and prohibits location of an abortion facility within 1,500 feet of any church, school or kindergarten.

Final Adoption of Minimum Standards for Operation of Mississippi Hospitals

Allowed for the operation of freestanding emergency departments.

Final Adoption of Minimum Standards for Personal Care Homes Assisted Living

Amended the regulations to provide for the distribution of educational information on influenza disease to residents and provides that facilities are not required to provide or pay for any vaccination against influenza.

Final Adoption of Minimum Standards for Personal Care Homes Residential Living

Amended the regulations to provide for the distribution of educational information on influenza disease to residents, and provides that facilities are not required to provide or pay for any vaccination against influenza.

Modifications to Mississippi Regulations for Control of Radiation

Established fee schedule.

Regulation Changes for Environmental Health Fees – On-Site Wastewater

Modified fees and established new fees.

Regulation Changes for Environmental Health Fees – Milk and Frozen Desserts

Revised fees and established new fees for frozen desserts, milk and milk products.

Regulation Changes for Environmental Health Fees – Food

Amended the regulations to revise fees and established new fees for bottled water, retail food establishments, ice production facilities and manufactured foods.

Regulation Changes for Environmental Health Fees – Jail Sanitation Inspections

Amended the regulations to include an inspection fee for correctional facilities.

Final Adoption of Regulations for Tanning Facilities

Amended the regulations to include a registration fee.

Final Adoption of Amendments to Regulations concerning Public Health Statistics regarding the provision of free death certificates

Provided that up to five certified copies of a death certificate will be furnished, free of charge, to any honorably discharged veteran of the Armed Forces who dies in Mississippi or while serving on active duty, upon written application by any recognized Veterans Service Officer.

OCTOBER 2016

Final Adoption of Amendments to Minimum Standards of Operation of Prescribed Pediatric Extended Care (PPEC) Centers

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable. Clarified and revised rule regarding required reporting; qualifications for Director of Nursing; vehicle registration used for transporting; facilities guidelines for design and construction of health care facilities; and corrects the word hospital to PPEC regarding plan submission.

Final Adoption of Amendments to the Minimum Standards of Operation of Pediatric Skilled Nursing Facilities

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to the Minimum Standards of Operation of Home Health Agencies

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to the Minimum Standards of Operation for Abortion Facilities

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to Minimum Standards for Operation of Mississippi Hospitals

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable. Requires fees to be paid via certified check or money order.

Final Adoption of Amendments to Minimum Standards for Hospice

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to Minimum Standards for Operation of Ambulatory Surgical Facilities

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees are nonrefundable.

Requires submission of an annual report; licenses are issued only for premises and person named in the application and are not transferable or assignable. License must be posted in a conspicuous place on the premises.

Final Adoption of Amendments to Minimum Standards for Operation of Birthing Centers

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable. Requires submission of an annual report; licenses are issued only for premises and person named in the application and are not transferable or assignable. License must be posted in a conspicuous place on the premises.

Final Adoption of Amendments to Minimum Standards for Operation of Facilities for the Aged or Infirm

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to Minimum Standards for Operation of Intermediate Care Facilities for Individuals with Intellectual Disabilities

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to Minimum Standards for Operation of Psychiatric Residential Treatment Facilities

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to Minimum Standards for Operation of Adult Foster Home Facilities

Brought the regulations into compliance with 2016 HB 289 striking specific licensure fee and allows the Mississippi State Board of Health to set licensure fees; fees are nonrefundable.

Final Adoption of Amendments to Minimum Standards for Utilization Review Agents

Struck specific licensure and renewal fees allowing the Mississippi State Board of Health to set the fees.

Final Adoption of the Regulations Governing the Registration of Medical Radiation Technologists

Amended the regulations to clarify an exception to the registration requirements for Medical Radiation Technologists for students.

Final Adoption of Amendments to Regulations Concerning Public Health Statistics

Amended regulations to increase the cost of birth certificates, death records and statistical report of marriages.

Proposed Amendments to the Rules and Regulations Governing Reportable Disease and Conditions / Mississippi Healthcare Data Registry System

Amended the regulations to clarify the name of the system and to specify that one member of the Data Use Council shall be designated by the Mississippi Hospital Association; to define the Mississippi Data Advisory Committee; to allow a fee to be assessed for patient abstract data; and to clarify hospital reporting requirements.

JANUARY 2017

Final Adoption of Modifications to the Regulations Governing Fluoridation of Community Water Supplies

Amended regulations to provide clarification regarding the public water system's responsibility to operate fluoridation treatment facilities to price the optimum dose necessary; allowed public water system to discontinue community fluoridation pursuant to agency policy.

Final Adoption of Emergency Medical Services (EMS) Rules and Regulations

Amended regulations to reflect more frequent reporting of EMS date and provide stricter standards for invalid transport services.

Final Adoption of Amendments to the Rules and Regulations Governing Reportable Diseases and Conditions

Amended regulations to add Congenital Zika Infection to the list of Reportable Diseases; to request submission of Streptococcus pneumonia isolate in patients older than 12 years of age; and updated rabies section to align with the updated recommendations contained within the 2016 Compendium of Animal and Rabies Prevention and Control.

CON Review Manual

Revised the Certificate of Need Review Manual to comply with 2016 Senate Bill 2661 amendments to the Certificate of Need Law, and to more accurately reflect agency policies and procedures.

APRIL 2017

Final Adoption of Amendments to On-site Wastewater Regulations

Amended regulations to change the acquisition and use of Professional Development Hours; and clarified Certified Installer maintenance responsibilities.

Final Adoption of Amendments to Mississippi Qualified Health Center Policies and Procedures Manual

Amended regulations to change the quorum requirement for the Mississippi Qualified Health Center advisory council; and to eliminate the restriction on which members could serve as Chair and Vice–Chair.

CHANGES IN STATE LAW

Legislative Update for the 2017 Mississippi Legislative Session:

HOUSE BILL 456. Signed 03/01/17. Effective 07/01/2017.

– Extends the repealer on the Infant Mortality Reduction Collaborative enabling statute, 41–89–21, Mississippi Code of 1972, to July 1, 2020.

HOUSE BILL 457. Signed 03/20/2017. Effective 07/01/2017.

- Amends the law on personal care homes to delete the repealer on some provisions of the law that allow personal care home residents to remain in a personal care home even if a licensing agency determines that skilled nursing services are appropriate; provides for rules restricting the handling of personal care home resident's personal deposits by the director of the personal care home; and requires that personal care homes maintain records relating to health conditions and medications.

HOUSE BILL 494. Signed 03/10/2017. Effective 07/01/2017.

- Authorizes the Mississippi State Department of Health to establish the Maternal Mortality Review Committee to review maternal deaths and establish strategies to prevent maternal deaths, and provides that the Committee shall be assigned to MSDH for administrative purposes, and requires MSDH to designate support staff; requires the Committee to submit an annual report to the House and Senate Public Health Committees, including the numbers, causes and relevant demographic information on maternal mortality in Mississippi and appropriate recommendations on how to most effectively direct state resources to decrease maternal mortality; requires that data for the Committee's review and reporting be provided to the Committee by agencies, officials and health care providers having information necessary for the Committee to carry out its duties; requires physicians, hospitals and pharmacists to provide reasonable access to the Committee to relevant medical records associated with a case under review by the Committee and provides immunity to physicians, hospitals and pharmacies providing access to those records; provides that all proceedings and activities of the Committee, opinions of members of the Committee formed as a result of those proceedings and activities, and records obtained and created as a result of the Committee proceedings and activities are confidential and not subject to the Mississippi Public Records Act; authorizes the Committee to compile reports of aggregated, non-individually identifiable data on a routine basis for distribution in an effort to further study the causes and problems associated with maternal deaths.

HOUSE BILL 996. Signed 03/15/2017. Effective 07/01/2017.

Requires the Mississippi State Department of Health to create and offer training for first responders on the signs and symptoms of opioid overdose; the protocols and administration of opioid antagonists; the signs and symptoms of an adverse reaction to the antagonist; the protocols and procedures to stabilize a patient if an adverse reaction occurs; and the method of opioid antagonist being taught. The law requires that the training be overseen by a physician or pharmacist licensed in Mississippi. Allows the employer of the first responder to provide the required training. Requires that first responders be trained every three years.

CHANGES IN STATE LAW

HOUSE BILL 1330. Signed 04/05/2017. Effective 07/01/2017.

- Repealed the Mississippi Health Policy Act of 1994 (§§41-95-1 through 41-95-4).

SENATE BILL 2006. Signed 03/15/2017. Effective 07/01/2017.

Requires MSDH to adopt regulations to specify the information to be provided in
the written report furnished to patients receiving mammogram services under the
federal Mammography Quality Standards Act, 42 USC §263b. Any information
that MSDH requires to be provided in the report must be evidence based,
consistent with accepted medical standards, and not inconsistent with the federal
Mammography Quality Standards Act or regulations promulgated under that act.

SENATE BILL 2194. Signed 03/27/2017. Effective 07/01/2017.

- Amended the following sections of the Mississippi Controlled Substances Act: section 41–29–113, Mississippi Code of 1972, to revise Schedule I of the Controlled Substances Act to include AH–7921, Butyryl fentanyl, and betahydroxythiofentanyl. This section was also amended to clarify the chemical description of synthetic cathinones. Sections 41–29–115, 41–29–117, and 41–29–119 were amended to exclude pentazocine from Schedules II and III and add it to Schedule IV. 41–29–119 was also amended to add Eluxadoline. Section 41–29–121 was amended to add Brivaracetam to Schedule V.

SENATE BILL 2289. Signed 03/20/2017. Effective 07/01/2017.

 Reenacted and extended the repealer on the sections of the law that create the Mississippi State Board of Health, establish the position of Executive Officer of the Mississippi State Department of Health, and establish the Mississippi State Department of Health and prescribe its duties and powers.

SENATE BILL 2372. Signed 03/27/2017. Effective upon passage.

 Authorizes the Mississippi State Department of Health to issue five new hospice licenses.

SENATE BILL 2610. Signed 3/20/2017. Effective upon passage.

Extended the repealer on and amended section 41–29–136 to more narrowly
define the properties of the cannabidiol preparation and amended the
Mississippi Controlled Substances Act, 41–29–113 to clarify that the preparation is
exempt from control under Schedule I.

SENATE BILL 2828. Signed 03/20/2017. Effective 07/01/2017.

 Enacts the EMS Personnel Licensure Interstate Compact to facilitate the movement of EMS personnel across state boundaries in the performance of their EMS duties and provides that the provisions of the compact shall be implemented by the Mississippi State Department of Health.





INFANT MORTALITY IN MISSISSIPPI, 2007-2016







AIDS RATES BY YEAR, UNITED STATES AND MISSISSIPPI, 2006-2015




TUBERCULOSIS RATES BY YEAR, UNITED STATES AND MISSISSIPPI, 2007-2016



WEST NILE VIRUS RATES BY YEAR, UNITED STATES AND MISSISSIPPI, 2007-2016




VACCINATION COVERAGE AMONG CHILDREN 19-35 MONTHS, BY YEAR, MISSISSIPPI AND UNITED STATES












