| 1. | Approval of November 6, 2020 minutes | A motion was made by Ms. Friend and seconded by Ms. Turner to approve the minutes of the November 6, 2020 minutes. The motion passed.  |
| 2. | Election of officers                 | Ms. Wang informed the Council that an election of a chairperson and secretary was on the agenda. Mr. Crowe was re-nominated as chairperson, Dr. Grillis made the motion, and Ms. Gore seconded. The nomination was approved. Ms. Gore motioned to nominate Dr. Grillis for secretary, Ms. Friend seconded. The nomination was approved.  |
| 3. | Passing score for ASHA exam (Praxis) | The Council was informed that ASHA's standard current passing score is 162. Ms. Gore motioned to set Mississippi's passing exam score at 162, Dr. Grillis seconded. The motion passed.   |
| 4. | Complaint report                     | Ms. Wang informed the Council that there were currently 3 complaints. One was from a licensee that forged a patient's signature and did not make patient visits. The complaint was closed with a pending consent order waiting for a signature. The second complaint is pending, still waiting to hear from the licensee, have already conducted an interview with the employer. The third is a temporary license applicant, who had been working without being issued a license. The complaint will be closed once the consent order has been signed by both parties. |

| 2.    | Department of Education     | Mr. Simkins informed the council that there are currently separate licenses for the Department of Health and Department of Education speech-language pathologists and that Ms. Morrow reached out to the Department of Education for contact and more information but had yet to receive a response. Mr. Simkins informed the Council there is a new bill in the legislature that would appoint a new board, the State Board of Examiners for Audiology and Speech-Language Pathology. If the bill passes, it will eliminate the two separate licenses, and both health and education speech-language pathology licenses would be under this board, but that the bill is not currently out of committee nor passed. |
