1.	Approval of June 6, 2022 minutes	A motion was made by Mr. Stroud and seconded by Ms. Shirley to approve the minutes of the June 6, 2022 minutes. The motion passed.
2.	2022 Renewal Update	Ms. Gunn informed the Council of the 2022 renewal numbers: 388 active ATs and 45 closed ATs
3.	CE Audit Notice	Ms. Wang gave a print out of receipts that were forwarded to MSDH email that gave statement in red regarding CE audit. Also, Ms. Wang informed that the statement also is given upon renewal prior to submitting renewal and payment. Mr. Stroud asked if there was another way to notify licensees, Ms. Morrow informed the Council that the notification during renewal as well as on the receipt is currently the best means of notifying licensees. Also, Ms. Wang informed the Council that when the 2 nd renewal reminder is sent approximately 2 weeks prior to the expiration date, those that have been audited and have not submitted their CEs will also receive the email that their license will expire because of their "pending" status.
4.	Complaint Report	Ms. Wang informed the Council that an affidavit was filed against one of the JSU employees that is identifying himself as an AT; could not file affidavit on other one a he is listed as first aid responder. Ms. Wang also informed the Council of the 2 nd complaint received against the PT, have contacted the MS Board of PT, and that the complaint against the PT will need to be submitted directly to them, and if he is violating not only PT regulations, but they feel that he is also violating AT regulations they will contact MSDH.
