PARTICIPANT UPDATES

Cash Value Benefits (CVB) Changes

The cash value benefit (CVB) amount WIC participants use to purchase fresh, frozen, and canned fruits and vegetables has changed.

New amounts:

- \$26 for child participants
- \$47 for pregnant and postpartum participants
- \$52 for fully and partially breastfeeding participants

The Federal Fiscal Year 2024 CVB amounts are based on the Continuing Appropriations Act, 2024 and Other Extensions Act. MSDH WIC will notify WIC participants of any changes to these rates for Federal Fiscal Year 2024.

<u>Use of WIC and SNAP</u>

If a participant has a SNAP card, please advise them to swipe their WIC benefits card first. Lack of swiping WIC first may cause issues with redemption of available benefits during a transaction.

FORMULA UPDATES

<u>Reporting Shortages</u>

Please report any issues ordering or receiving infant formula to the State Office by sending an email to vmu@msdh.ms.gov. If formula is unavailable due to shortages, please direct WIC participants to complete the participant complaint form or call their local health department.

<u>New Formulas</u>

We are working to add the **12.4 oz. container of Enfamil Reguline** to the standard formulas list. More information will be provided as it is made available.

PRODUCE MAPPING

Produce mapping is a functionality of your integrated point of sale (POS) software that allows you to link a UPC to a PLU listed in the MS WIC Approved Product List (APL). If produce mapping is not completed, eligible produce items cannot be purchased with eWIC. It is each vendor's responsibility to map all required fresh fruits and vegetables.

AUTHORIZATIONS

New Period for 2024...

The open enrollment period or new authorization period is **March 1 – May 31, 2024.** Only applications received during the open period will

be processed. Applications will only be accepted outside of the normal vendor application period for participant access, emergency situations, and/or change of store ownership.

REAUTHORIZATION

All current vendors must be reauthorized

Vendor agreements expire on **September 30, 2024**. To remain a WIC- authorized vendor in Mississippi, you will need to re-apply. The open application period to reapply is tentatively set for **April 1 - May 31, 2024**. Applications cannot be accepted before or after this timeframe.

You can follow these 6 easy steps to make sure you remain a WIC Authorized Vendor.

- Step 1: Visit www.freshnewwic.com.
- Step 2: Review the WIC Program Vendor application sample (as this information has changed).
- Step 3: Select the WIC Vendor Application link and complete the application.
- Step 4: Attach supporting documentation. All attachments should be completed in its entirety.
- Step 5: Wait to hear from the Vendor Management Team for next steps.
- Step 6: Sign the WIC vendor agreement.
