The install is ready and 5 hospitals have volunteered to pilot test. Hopefully, by the end of the year, we will be ready to deploy to everybody. Gerald will test from a region perspective.

The DOH is looking into purchasing Outcomes. Also, Dashboard will be utilized by the region. Ms. Kyle requests that a short presentation on Outcomes and Dashboard be presented at our next meeting.

ICD10:

DI is working on implementing ICD 10 hopefully by October 2014. We will switch in collector in January 2015. Ms. McFarland will also look into providing education in 2014. Please let DOH know of any educational experiences in future.

- MEMSIS Interface

Still pending DI host for the State, then the vendors will be in contact with each other. No timeline is available.

- **Dataset Evaluation and Standardization**

- Minimum Data fields standard
Ms. McCullum will report on this at next meeting. See handout in packet. If you would like to help on this task force then please let Ms. McCullum know. The task force is trying to reduce fields to only the fields that are being used.
- Co-morbidity listing
Some cannot be mapped. A hand out is included. Try not to use non trauma diagnosis. A comorbidity and complication list is included in packet. All new items are highlighted in yellow. We would like for NTDB to map from non trauma diagnoses as well as the QA filter page.

- **Registry Inclusion Criteria Task Force**

- Recommendation for MTAC
See Mississippi Trauma Inclusion Criteria Handout in Packet. The group is trying to streamline our criteria with national criteria. Ms. Smalley reported that Ms. Perrigin's region is worried about increasing numbers due to adding same height falls with hip fractures over 65

years of age. She would like to change age to > 75 years. All patients with extremity and hip fractures: We need to define what a trauma patient is. The only people that we are excluding are the active people that are walking. Ms. Smalley thinks that we should think about our resources. The group voted to change age to 70 and send to MTAC.

We would like to add air transfer so we can track them. Lengthy discussion concerning why to add this. Is this truly an EMS issue? We will table until Ms. Kyle can arrive. Ms. Kyle present. Motion made and approved following vote to delete air transfer from list and send to MTAC.

- **NTDB Participation for Trauma Center Re-Designation**

Has been sent to MTAC but not approved yet.

- **Committee Updates**

- MTAC and EMS Advisory Committee
 - MTAC – Did not meet. A strategic planning group met on the coast. Discussion from that meeting will be presented at our next meeting.
 - EMS Advisory Committee- Did not meet due to strategic planning committee.
- PI Subcommittee – The Subcommittee is reviewing the activation criteria for possible revisions. Specific changes are under discussion and nothing has been approved yet. A pilot will be conducted in the north and on the coast if their board approves them. This committee needs a physician chair. They are hoping to find several and rotate them.
- Mandatory State Audit Filters: Mr. Nottenkamper asked group for any recommendations and Ms. Kyle discussed mandatory state audit filters. She has found that other states do this. Hospitals would love direction as far as PI goes.
- March 20-21 is coming to help education TPM. Ms. Kyle and Ms. Kyle are working with Ms. Perrigin to put a course together as well.

MS Trauma Registry Google Group:

DOH is still working on this. Hopefully will be implemented by the 1st quarter of 2014. The DOH has a web resource list that is given out. There is a NTDB google group but this one will be specific to MS but available to all.
