The meeting was called to order by Chairman Luke Lampton, MD.

Upon motion by Dr. Hill and second by Mrs. Aldridge to approve the Consent Agenda, the Board unanimously approved the motion.

## **Regular Agenda Items:**

Item 3 Recommended Closure of Tombigbee Home Health Office, Region 4B, Houston, MS; Tombigbee Home Health Office, Region 4C, Columbus, MS; Southwest Home Health Office, Region 7A, Natchez, MS

Based upon a finding of the Board that there are adequate private or other home health services in the area being served by the State Department of Health home agency, office, branch office or clinic, and upon motion by Mrs. Rea and second by Mrs. Aldridge to approve the closure of these three home health agencies, the Board unanimously approved the motion.

Upon motion by Dr. Anthony to retain the leadership of Dr. Luke Lampton as Chairman of the Board and Dr. Hill as Vice Chairman of the Board and second by Mr. Langton, the Board unanimously approved the motion.

Dr. Lampton restructured the Audit Committee to include Dr. Thad Waites as Chair, Dr. Elayne Anthony, Dr. Tad Barham, Mr. Ed Langton and Mr. Bobby Moody. Dr. Lampton will participate as a side member. The Audit Committee will conduct an annual review of the State Health Officer and Internal Auditor by October, 2014.
